REGULAR MEETING JULY 14, 2020

The Peach County Board of Commissioners held its Regular monthly meeting at 6:00 p.m., Tuesday, July 14, 2020, in the Commissioners Meeting room located at 213 Persons Street Fort Valley, Georgia with all members in attendance except for Vice Chairman Hill and Commissioner Bryant who attended via Go-to-Meetings video conference platform. Chairman Moseley called the meeting to order, welcomed those present and opened the meeting with prayer.

MINUTES:

Regular Meeting – June 9, 2020 – Commissioner Yoder moved to approve the minutes as presented. Vice Chairman Hill seconded the motion. Motion carried unanimously.

Called Meeting – June 26, 2020 – Commissioner Lewis moved to approve the minutes as presented. Vice Chairman Hill seconded the motion. Motion carried unanimously.

ANNOUNCEMENTS & UPDATES:

Chairman Moseley welcomed Mr. George Hamilton to the meeting and congratulated him on his retirement from the Peach County Board of Assessors which was effective June 30, 2020. Chairman Moseley presented Mr. Hamilton with a plaque on behalf of the Board of Commissioners to thank him for his 23 years of dedicated service to Peach County.

Chairman Moseley welcomed Kemoye' Caldwell-Latimore and Stephania Lopez, Peach County Youth Commissioners to the meeting and congratulated them on graduating from Peach County High School. Chairman Moseley presented a plaque to the both students honoring them for their participation in the Peach County Youth Commission program for the past two years. Ms. Latimore and Ms. Lopez expressed how much they have learned about local government during the course of the Program. They thanked Ms. Tumbia Ashmon and Ms. April Hodges for their assistance and support throughout the program.

Commissioner Yoder provided the Board with an update regarding Middle Flint Behavioral Health Care services. Mr. Yoder advised that the state has ~~not~~ proposed ~~any~~ budget cuts for mental health services ~~at this time~~, but Middle GA Flint Behavioral will <sup>a \$500,000</sup> ~~not~~ reduce services.

Commissioner Yoder provided an update regarding Animal Control, he stated that the location for the site is locked in place. A designated committee for Animal Control is making arrangements to tour other county facilities in our area to gain additional insight on how the facility can be constructed. The committee has also discussed ordinance specifics to help regulate animal control within the County.

Chief Lawrence Z. Spurgeon, Public Safety Director, City of Fort Valley advised that he would like to commend Jeffery Oliver, Firefighter, on his performance during the City of Fort Valley's recent missing persons case. On July 25, 2020, the Fort Valley Department of Public Safety was dispatched to a report of a Missing Person. Tragically the subject of the investigation was discovered deceased in an accident scene off HWY 96 East in Fort Valley. Fire Fighter Oliver performed above and beyond during this extremely chaotic incident. His willingness to go the "extra mile" brought this event to close and hopefully gave the family some semblance of peace. His performance demonstrates his commitment to excellence in his chosen profession. His extraordinary efforts and accomplishments during this tragic incident reflect great credit upon himself, The Peach County Fire Department, and Peach County.

David Parrish, Recreation Director presented the following quotes for new playground equipment to be installed at South Peach Park:

Mr. Parrish advised that he recommends going with the proposal submitted by Play South for option #1 in the amount of \$191,480.00 due to the company providing more equipment for the cost provided. Vice Chairman Hill moved to approve the proposal from Play South as recommended by Mr. Parrish in the amount of \$191,480.00. Commissioner Bryant seconded the motion and the motion carried unanimously.

Commissioner Lewis moved to go into a Public Hearing for the proposed Broadband Ordinance at 6:30 p.m. Commissioner Yoder seconded the motion, and the motion carried unanimously.

- - PUBLIC HEARING - -

April Hodges, Assistant County Administrator/County Clerk, presented a proposed Broadband Ordinance for adoption by the Board.

Commissioner Yoder advised that the ordinance was to allow Peach County to become a Broadband Ready Community and to put a process in place to attract additional companies that provide broadband services to Peach County.

Ms. April Hodges advised that it had been advertised, and there has been no response to the advertisement.

Chairman Moseley asked for those speaking in favor of the ordinance.

Ms. Sabrina Thorpe, advised that she was in favor of the ordinance because where she currently resides, is out of range for high speed internet connection.

Chairman Moseley asked for those speaking in opposition of the ordinance. No one spoke in opposition

There being no further comments to be made concerning the proposed Broadband Ordinance, Vice Chairman Moseley moved to close the Public Hearing at 6:37 p.m. Commissioner Yoder seconded the motion, and the motion carried unanimously.

Daniel Garcia-Flores, Purchasing Manager advised that the following quotes were received for the EMA Storage building.

Mr. Garcia-Flores recommended the board accept the lowest quote from Eagle Carports for the Building Structure and Ronnie Knight for concrete flooring.

Jeff Doles, Fire Chief/EMA Director, advised that the presented quotes for the building structure does not include garage doors, they will have to be purchased separately. Commissioner Lewis asked what is the average cost for the doors. Chief Doles responded that they can range anywhere from \$2,000.00 to \$5,000.00.

After further discussion Commissioner Lewis moved to table the item until the next meeting to provide additional time for quotes to be solicited for garage doors. Commissioner Yoder seconded the motion and the motion carried unanimously.

Wayne Smith, Public Works Director, presented a quote from Maxair Mechanical in the amount of \$8,200.00 to upgrade the Jace engineering software and equipment located at the Public Works office. Commissioner Yoder moved to accept the quote as presented. Commissioner Lewis seconded the motion and the motion carried unanimously.

Paul Schwindler, County Engineer advised that Commissioner Yoder requested that he solicit quotes to purchase a traffic count that could verify traffic speed. A Blackcat II Radar Recorder, from JAMAR Technologies, Inc. is an inexpensive solution that can be used to gather not only speed data, but it can also gather two-way traffic counts. Mr. Schwindler added that the price to purchase the equipment is \$4,747.00, if approved, the following budget amendment is needed from contingency to appropriate funding for this purchase:

Commissioner Lewis moved to authorize Mr. Schwindler to Purchase a Blackcat II Radar Recorder from JAMAR Technologies, Inc. in the amount of \$4,747.00 and to approve a budget amendment from contingency for this purchase. Commissioner Yoder seconded the motion and the motion carried four to one with Commissioner Bryant opposing.

Paul Schwindler, County Engineer presented a proposal for DEH Disaster Recovery, LLC in the amount of \$4,850.00, in addition of the contract for work on Taylors Mill Road and Bassett Road. Mr. Schwindler advised that the additional cost is for the re-establishment of the vegetation and re-seeding of disturbed areas of resident's lawn on the right-of-way area. Commissioner Lewis moved to approve the proposal as presented. Commissioner Yoder seconded the motion and the motion carried unanimously.

NEW BUSINESS:

Tisa Horton, President of the Georgia Peach Festival, requested that even though the Peach Festival was canceled for this year, the Festival is requesting that funding allocated for 2020 still be provided to the Peach Festival this year to cover expenses for stage rental and fireworks. Commissioner Lewis moved to approve to provide funding to the Georgia Peach Festival as requested. Commissioner Yoder seconded the motion and the motion carried unanimously.

Sabrina Thorpe, Peach County Citizen, advised that she had concerns regarding dilapidated houses and abandoned homes in the Gano Community. Prior to the meeting Ms. Hill contacted her and they were able to come up with a plan to develop a community group for regular clean up and to contact owners regarding the abandoned property. Rickey Blalock, Zoning Administrator, advised that the Gano area is one of the locations that he has to deal with all the time. He has contacted seven (7) properties that are in really bad condition and sent letters to the owners. The letter states that the owners have 30 days to bring the property up to guidelines.

Michaela Jones, County Administrator, advised that a letter was received from State Properties Commission regarding the Workforce Development Center. State Properties Commission is requesting to exercise its option to renew the term of the original agreement for an additional one (1) year for the period beginning July 1, 2020, and ending June 30, 2021. Vice Chairman Hill moved to approve the

request from State Properties Commission to renew the lease agreement for the Workforce Development Center as presented. Commissioner Lewis seconded the motion and the motion carried unanimously.

Alfonzo Ford, EMS Director has requested approval from the Board to apply for the ACCG Safety Grant to purchase UV sanitizer lights to sanitize surfaces within county buildings and vehicles. Commissioner Bryant moved to approve the request as presented. Commissioner Hill seconded the motion and the motion carried unanimously.

Commissioner Bryant advised that she was contacted by a citizen that had concerns regarding not being able to pay business license fees online. Ms. Bryant expressed that she would like to see this added to the County website and also for the website to be redesigned for easier use by citizens. No action was taken by the Board.

Commissioner Lewis advised that the CARES Act has grant funding that will help fund Robins International Industrial Park Roadway and Infrastructure Improvements. Commissioner Lewis is requesting to send a letter of support stating that Peach County would be the lead agency to match \$1,500,000.00, with the total project cost being \$6,900,00.00. Peach County would also have to enter into an Intergovernmental Agreement with the other agencies. Commissioner Bryant moved to approve the letter of support for the grant funding. Commissioner Yoder seconded the motion. Motion passed 4-1, with Chairman Moseley abstaining due to conflict of interest.

Commissioner Bryant advised that she would like the County to enforce all employees to wear a mask due to COVID-19 concerns.

Attorney Liipfert responded that he didn't know if it is legal for the County to require employees to wear a mask, but he would look into the Georgia constitution to see if it is legal. After further discussion, no action was taken.

Commissioner Lewis advised that a budget amendment is needed from contingency in the amount of \$454,971.00, to complete the Courtland Avenue entrance to South Peach Park. The project was not budgeted for FY2020, and the funding has to be appropriated in order to start construction.

Commissioner Bryant expressed her concerns regarding not having any remaining funding in contingency since it was still three months remaining in the FY2020 Budget.

Commissioner Lewis moved to accept the budget amendment as presented. Commissioner Hill seconded the motion and the motion carried four to one with Commissioner Bryant opposing.

Paul Schwindler, County Engineer, advised that a budget amendment is needed in the amount of \$23,000.00 to complete the repairs to the front walkway brick pavers at the Courthouse. Commissioner Yoder moved to approve the budget amendment as presented. Commissioner Lewis seconded the motion. Motion carried unanimously.

Vice Chairman Hill moved to terminate Executive Session at 8:04 p.m. Commissioner Bryant seconded the motion, and the motion carried unanimously.

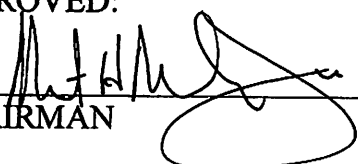
